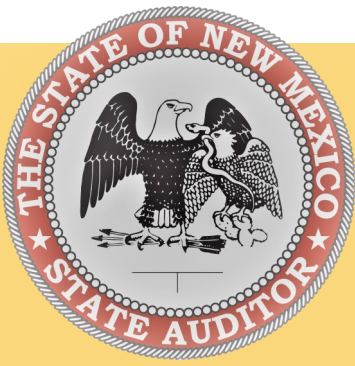

New Mexico Elected Officials: 2018 Financial Disclosures at a Glance

Original 4/11/18, Data Updated 4/17/18

Executive Summary

Seeking Transparency

In New Mexico, certain candidates and elected officials are required to file Financial Disclosure Statements, which reveal their sources of income and potential conflicts of interest. These disclosures are intended to deter corruption, enable the public to evaluate any conflicts of interest, and increase public confidence.

Candidates running for the state legislature, or statewide offices, must fill out a Financial Disclosure Statement for the previous calendar year and file it with the Secretary of State's office. Sitting elected or appointed officials must also file Financial Disclosure statements in January of each year.

However, on the Secretary of State's website, these Financial Disclosures can only be viewed individually, and there is no single document which lists all of the information in one place.

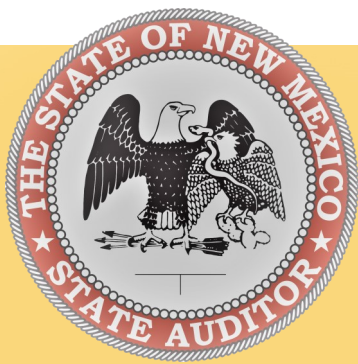
A Single List

In order to make the information more accessible to New Mexicans, the State Auditor's Government Accountability Office has compiled and summarized the 2018 Financial Disclosures for officials currently serving in a state-wide office, plus state representatives and senators into a single document.

The office has compiled the information from the Financial Disclosures for seven (7) items required to be disclosed:

(1) Name of Elected Official, (2) Elected Official's Employer or Sources of Income, (3) Elected Official's Spouse's Employer or Sources of Income, (4) All Sources of Income over \$5,000 Annually, (5) Goods and/or Services to State Agencies over \$5,000 Annually, (6) Official or Spouse Engaged in Lobbying and lastly, (7) Other Financial Interests – Potential Conflicts of Interest.

The Financial Disclosures are arranged in alphabetical order by last name, and include the responses for all 42 state senators, 70 state rep-

representatives, and 6 statewide elected officials – The Governor, Attorney General, Commissioner of Public Lands, Secretary of State, State Auditor and State Treasurer.

The data compiled was taken directly from the 2018 Financial Disclosure Statements submitted by each person, verbatim, when words were used. If the report contains the word “none,” then OSA put “none” in the spreadsheet. If the report states “N/A,” the OSA put “N/A” in the spreadsheet. If a report simply contains a line through a section, OSA listed “Line through on form” in the spreadsheet. If the report leaves a section blank, OSA listed “Left blank on form” in the spreadsheet.

Income and Potential Conflicts of Interest

The Financial Disclosures Act, § 10-16A-3(C), requires a person to disclose the name of the person’s employer, and his or her spouse’s employer. At least 28 of the Disclosures reviewed listed the person’s occupation as retired, while 24 reporting individuals identified self-employment. Seven (7) individuals listed public schools as their employer.

The Act requires individuals to list any goods or services provided to state agencies for over \$5,000 per year. Fourteen (14) of the reports disclose goods or services provided by an elected official to state agencies.

Officials must also disclose “all sources of gross income of more than five thousand dollars (\$5000)” to each person covered in the disclosure statement, identified by general category descriptions that disclose the nature of the income source, in the following broad categories: law practice or consulting operation or similar business, finance and banking, farming and ranching, medicine or healthcare, insurance (as a business and not as payment on an insurance claim), oil and gas, transportation, utilities, general stock market holdings, bonds, government, education, manufacturing, real estate, consumer goods sales with a general description of the consumer goods and the “other” category with direction that the income source be similarly described.”

Despite this requirement, four (4) financial disclosures contain no reported sources of income at all for either the elected official or the official’s spouse in this category.
