Attendees will practice what they learn through case studies and application. We'll then close the session with a look at common frauds in the governmental arena and prevention techniques.

DAY 2: Governmental Auditing Update

We'll start day 2 with a review of the new ethics interpretations impacting CPAs from the AICPA's Professional Ethics Executive Committee. We'll then review some proposed changes to Yellow Book that are expected to be finalized by the end of the year. We'll then take a look at what is going on at the AICPA with a focus on SASes 142 through 149. We'll consider the impact of standards like NOCLAR and risk assessment and how they will impact upcoming engagements. After lunch we'll switch gears to look at changes in Single Audits including the new Compliance Supplement as well as alternative engagements to Single Audits that may help smaller governments. We'll close with common deficiencies in Single Audits.
