The Office of the State Auditor will consider adopting amendments to the Audit Rule at a public hearing on March 14, 2024, at 9 a.m. at the New Mexico Society of Certified Professional Accountants at 3400 Menaul Blvd. NE, Albuquerque, NM 87107. The hearing will be a hybrid-virtual meeting and members of the public may attend, listen, and participate via live streaming or telephone as well as by attending in person.
